

## **Activity: Individual Reflection Quiz**

### Objective:

This activity will help students recall and reflect on the key concepts they have learned throughout the course. By answering individual questions, participants will engage with the material and test their knowledge on **Digitalization**, **Data Management**, and **GDPR Compliance**.

Duration:			
30 minutes			

### **Materials Needed:**

- 1. **Printed Quiz Sheets** or **Digital Quiz Forms** (depending on the setting).
- 2. Pens or Devices (if the quiz is digital).
- 3. **Timer** to manage the 30-minute duration.

#### Instructions:

- 1. Distribute the Quiz Sheets (or digital quiz links) to each participant.

  - o Encourage them to think critically and apply what they've learned.
- 3. **Time Allotted**: 30 minutes to complete the quiz.

#### 1. Define Digitalization:

## 2. Identify Two Key Benefits of Digitalization:

What are two main benefits of digitalization for businesses? Provide examples for each.

#### **Section 2: Data Sources and Management**

### 3. What are Internal and External Data Sources?

Define internal and external data sources and give one example of each.

## 4. Explain the Importance of Data Reliability:

Why is reliable data critical for business operations and decision-making? Mention one challenge in ensuring data reliability.

# 5. List Two Best Practices for Data Management:

Provide two best practices that businesses can follow to ensure effective data management.

## **Section 3: Data Protection and GDPR Compliance**

### 6. What is GDPR and Why is it Important?

Explain the main purpose of GDPR and why companies need to comply with it.

### 7. What Should a Company Do in the Event of a Data Breach?

List three steps a company should take in compliance with GDPR when a data breach occurs.

### 8. Identify Two Key GDPR Principles:

Choose two principles of GDPR (e.g., transparency, consent, data minimization) and briefly explain their significance.

## **Activity Wrap-Up:**

- After the quiz, the facilitator will go over the answers with the group, allowing participants to reflect on their performance and ask any remaining questions.
- **Optional**: Participants can score themselves based on the provided answers to get an idea of their understanding of the material.

### **Expected Outcome:**

- By the end of the activity, participants will have recalled and reinforced key concepts learned in the course.
- The individual reflection element allows participants to assess their understanding and apply the knowledge to their own context.
